#### **P3** Presentation About the Grant and Project Process

- Dan discussed the article needed for the May 2026 Town Meeting warrant for the project appropriation and a debt exclusion question on the ballot. He stressed that only the Select Board can vote to place the debt exclusion on the ballot. He has already had an initial conversation with the Town Accountant about our project. As OPM, his firm has been working on arranging for the survey and geotechnical report required for the application submission. The survey is expected today (Dec 4th) and the geotechnical report on Friday (Dec 5th). He said that Matt hopes to be done with his work by Dec 22nd.
- The Committee explained to Dan that there was concern about the Town Administrator signing the contract without providing her with any advance notice. Dan will call Lisa tomorrow (Dec 5th) to discuss the matter with her.
