Volunteer Release and Waiver of Liability

This Release and Waiver of Liability ("Release") executed on _____ [DATE]
by _____ [VOLUNTEER'S NAME] ("Volunteer")
releases the Town of Hanson and its officials, directors, employees, agents, and assigns
(collectively, "Town") from any and all claims, demands, lawsuits, cost and attorney's fees
arising from the services provided by the Volunteer to the Town. This Release and Waiver of
Liability shall bind any and all of the Volunteer's heirs, dependents, executors, and assigns.

The Volunteer desires to provide volunteer services to the Town. Said Volunteer understands
that the scope of his/her relationship with the Town is limited to a volunteer position and that
no compensation is expected in return for services provided by the Volunteer; that the Town
will not provide any benefits traditionally associated with employment to the Volunteer; and
that the Volunteer is responsible for his/her own insurance coverage in the event of personal
injury or illness as a result of any services performed by the Volunteer for the Town.

1. Waiver and Release: I, the Volunteer, release and forever discharge and hold harmless
the Town and its successors and assigns from any and all liability, claims, and demands
of whatever kind of nature, either in law or in equity, which arise or may hereafter arise
from the services I provide to the Town. I understand and acknowledge that this Release
discharges the Town from any liability or claim that I may have against it with respect to
bodily injury, personal injury, illness, death, or property damage that may result from
the services I provide to the Town or occurring while I am providing volunteer services.
2. Insurance: Further I understand that the Town does not assume any responsibility for or
obligation to provide me with financial or other assistance, including but not limited to
medical, health, workers compensation or disability benefits or insurance. I expressly
waive any such claim for compensation or liability on the part of the Town beyond what
may be offered freely by them in the event of injury or medical expenses incurred by
me.
3. Medical Treatment: I hereby Release and forever discharge the Town from any claim
whatsoever which arises or may hereafter arise on account of any first-aid treatment or
other medical services rendered in connection with an emergency during my tenure as a
volunteer with the Town.

4. Assumption of Risk: I understand that the services I provide to the Town may include activities that may be hazardous to me including, without limitation, inherently dangerous activities. As a volunteer, I hereby expressly assume risk of injury or harm from these activities and release the Town from all liability for injury, illness, death or property damage resulting from the services I provide as a volunteer or occurring while I am providing volunteer services for the Town.
5. Other: As a Volunteer, I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the Commonwealth of Massachusetts and that this Release shall be governed by and interpreted in accordance with the laws of said Commonwealth. I agree that, in the event that any clause or provision of this Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected.
